ELIGIBILITY FOR MEANS SCHOLARSHIPS :

- a. The scholarship shall be provided to eligible student of the first, second and third year of the B.Sc. in H&HA who obtains the highest percentage of aggregate marks, the minimum being 60% marks, in the First/Third/ Fifth Semesters Final Exams.
- b. The gross family income of the beneficiary from all sources **should not exceed Rs.3.00 lakhs (Rupees Three lakhs only) per annum.**
- c. **The student being offered this scholarship should not be in the receipt of any other scholarship. If the student is already holding a scholarship/stipend etc. under some other scheme, he/she will be required to exercise his option of choosing the scholarship that he/she proposes to avail.**
- d. The student is required to submit **an affidavit on non-judicial stamp paper of Rs.50/- (Rupees Fifty only) for Item B & C (as per format enclosed)**
- e. They are required to produce latest Income Certificate obtained from the competent authority on or after the issue of this notice i.e.,

THE MEANS SCHOLARSHIP SHALL BE WITHDRAWN IN CASE THE:

- The beneficiary is detained from appearing in examination on account of shortage in requisite attendance.
- Fails to submit his assignments in time.
- For having indulged in activities which are in violation of Institute rules and regulations.
- For having submitted false information in the application for the grant of financial assistance ship.
- The last date for submission of Application is **till 27.02.2024.**
- Incomplete applications will be rejected.
